Traffic Enforcement

PSCO Sal has been very proactive in monitoring the areas where speeding and traffic issues are and have been an issue in the past, This includes speed calming measures on and around Sandy Lane is well as monitoring weight rules in built up areas such as Norfolk drive.

Anti-Social Behaviour

A male was issued a community protection warning by the safer communities team from Melton Borough Council in company with the beat team on the 28/08/25. This was in relation to a male having engaged in numerous incidents of ASB and acting in a threatening manner to other residents where he resides. This will be monitored for the next 6 months and if there are any further issues reported then he will be issues with a community protection warning. We are working alongside the housing management who have also issued him with a tenancy warning.

Continued

□ Crime & Patrols

- A **female was charged** after misusing a public communication network, Following a previous guilty plea with relation to making false reports to emergency services.
- We have been supporting our response teams with **live incidents** throughout August too and completing high visible patrols often on foot in some of our hotspot areas.

Teamwork with other beat officers from our neighbouring beats, assisting them with visiting vulnerable persons, dealing with suspects of criminal activity and ongoing neighbour disputes.

- A **male** was arrested on suspicion of stalking and later for assaulting the same victim. He was released with bail conditions to protect the victim.

We have been supporting our response teams with **live incidents** throughout August too and completing high visible patrols often on foot in some of our hotspot areas.

□ Safeguarding & Welfare

Officers responded to **mental health-related welfare concerns**, including submitting a **safeguarding report** with the individual's consent.

□ Station Duties

- The team also supported the **front enquiry office**, handling a wide range of public enquiries including criminal reports, intelligence sharing, and general queries.

- We continue to deal with local issues such as Anti-social behaviour and safeguard vulnerable residents and cuckooing victims as and when we identify concerns.
- Our work is ongoing with local schools including engagement events.
- And lastly as 'Dedicated Neighbourhood Officers' we continue to work on and try find solutions with neighbour disputes. We also support our response colleagues and cover the front enquiry office too.
