

## **BOROUGH OF TELFORD & WREKIN**

### **Holyhead Road, Hollinswood Road, Snedshill**

#### **(TEMPORARY PROHIBITION OF RIGHT TURN) ORDER 2026**

**BOROUGH OF TELFORD & WREKIN** (hereinafter referred to as 'the Council') being the highway authority for the lengths of roads specified in Part 1 of the Schedule to this Order and shown hatched red on the attached plan TCB-544, is satisfied that the traffic in the said lengths of roads should be regulated because works are being executed on or near the roads.

The Council in exercise of its powers under Section 14(1) and Section 15(2) of the Road Traffic Regulation Act 1984 and all other powers enabling it **HEREBY MAKES THE FOLLOWING ORDER:-**

1. The Order shall be cited as **BOROUGH OF TELFORD & WREKIN Holyhead Road, Hollinswood Road, Snedshill (TEMPORARY PROHIBITION OF RIGHT TURN) ORDER 2026**.
2. The Order shall come into operation on 21st April 2026 for a period of eighteen months and may be extended as the Council are satisfied that the execution of the works in question will take longer.
3. While the Order is in operation:
  - (i) No person shall cause any motor vehicle to proceed in the lengths of roads specified in Part 1 of the Schedule to this Order.
  - (ii) Article 3(i) of this Order shall not apply to any motor vehicles being used for fire brigade, ambulance or Police purposes.
  - (iii) Article 3(i) of this Order shall not apply to motor vehicles being used to access property and premises which are only accessible from one or more of the lengths of roads specified in the Schedule to this Order.
4. An alternative route will be available for use while the Order is in force specified in Part 2 of the Schedule to this Order and shown hatched blue on the Plan.

### **SCHEDULE**

#### **Part 1**

##### **Roads to be Regulated**

Temporarily prohibit vehicular traffic turning right from Holyhead Road, Snedshill into access route to Aldi and Wickes Carpark.

Temporarily prohibit vehicular traffic turning right from Holyhead Road onto Hollinswood Road, Snedshill.

Temporarily prohibit vehicular traffic turning right from Hollinswood Road onto Holyhead Road, Snedshill.

#### **Part 2**

##### **Alternative Route**

The diversion route for vehicular traffic travelling in all directions will be signed on site.
