#### Let's bin illegal lending!

Stop Loan Sharks teamed up with Warrington Trading Standards, Unify Credit Union and the Warrington waste collection team recently to spread the word on the dangers of illegal lenders and promote safe borrowing options.

The waste collection team put stickers on bins at 35,000 homes across the area. That's at least 35,000 households that will see our messages about how to stay safe from loan sharks. Thanks to everyone involved in this project!

#### Financial crime specialist was a loan shark

A 58-year-old man from West London who worked as a qualified anti-money laundering specialist but ran an illegal money lending operation on the side has been handed a two-year prison sentence, suspended for two years.

Dharmendra Devji Solanki, aged 58, admitted charges of illegal lending and money laundering and appeared before Inner London Crown Court to be sentenced on Friday, June 27. The case was prosecuted by the England Illegal Money Lending Team in partnership with Ealing Council Trading Standards and the Metropolitan Police.

Passing sentence, the Judge, Recorder Shauna Ritchie told him: "You were, prior to these offences, a man of good character and knew more than most."

She said he took advantage of the borrowers and their insecurities and added: "You were fully trained in relation to financial crime. The business you engaged in survived by lending money to the financially vulnerable."

The court heard the defendant was arrested at his home in Bradley Gardens, West Ealing, in May 2022 following an operation by the IMLT. An Apple MacBook was seized at the time, which contained a CV in his name, showing he was 'Financial Crime CAMS Qualified' and listed the professional body Association of Certified Anti-Money Laundering Specialists.

#### Illegal lender locked up for 30 months

A 47-year-old West Bromwich loan shark has been jailed for 30 months after making thousands of pounds in profit by exploiting the 'financially vulnerable'.

Philip Walter appeared before Wolverhampton Crown Court on May 8, 2025 after admitting illegal lending and money laundering charges.

Passing sentence, Judge Simon Ward told him that he was a loan shark who caused 'human damage' to the vulnerable people he targeted.

The court was told he didn't use violence or direct threats, but Judge Ward said: "There will be some people for whom the snowballing of interest is as frightening as having their leg broken."

He said it was effectively stealing from people by charging interest and told Walter: "These are people that were absolutely desperate and thought that borrowing money from you was their only way out. When you did lend them the money, they had to pay you back at a rate way above anything that was appropriate or reasonable."

He added: "The whole point of prosecuting people like you is to stop people like you causing damage to the vulnerable and desperate."

The case was prosecuted by the England Illegal Money Lending Team (IMLT), working in partnership with Sandwell Trading Standards and West Midlands Police.

Mr Joseph Millington, prosecuting on behalf of the IMLT, told the court that Walter ran his illegal lending operation over a period of around six years, lending more than £375,000 to 58 people and receiving over £515,000.

A warrant was executed at Walter's home in Beeches Road West Bromwich in October 2023, following an investigation by the IMLT.

In defence, the court heard Walter had suffered from mental health problems, was working and had a partner and children. He started lending after being in debt himself.

Walter was sentenced to 22 months in jail for the money laundering offences and eight months for illegal lending, to run consecutively, giving him a 30-month total sentence.



We Will Help You Make The Call: New
campaign to support vulnerable borrowers

At Stop Loan Sharks, we understand that reaching out for help isn't easy - especially for those without access to a phone or computer, or without a safe, private space to make a confidential call.

For many, fear and uncertainty can also make it difficult to take that first step alone.

Yet for these people, life-changing help is only a phone call away.

That's why we're inviting our trusted partners and frontline organisations with public-facing offices to help us reach those vulnerable people by joining us in our new campaign: We Will Help You Make the Call

While we cover the whole of England and our officers are available 24-hours a day via the confidential helpline, we don't have a physical premises in every community. This campaign aims to bridge that gap.

The idea is simple: Community organisations offer a welcoming, safe space where people can access a phone or computer to contact the Stop Loan Sharks team in confidence. Whether it's a few quiet minutes in a back office or a staff member offering calm reassurance, your gelp can make all the difference.

The official launch is set for September, and a Liaise Officer may be in touch in the coming weeks with more details.

If it is something you can help with, you'll be offered:

- A full resources pack, including leaflets and posters as well as social media content
- Window signage to show your organisation is an official Access Point
- A practical guide for staff on how to support someone making the call
- A press release template to help you share the news locally

# News from Scotland: How to enjoy a shark-free summer

Back to school means buying new clothes, shoes, pens, bags and more

If you feel that you have nowhere to turn to borrow money, don't choose a loan shark - there's

In the run up to the new school term, many families will feel under increasing pressure to spend money on uniforms, bags, stationery and lunches. They may feel that they have no option but to borrow money from a loan shark to help pay bills. The Scottish Illegal Money Lending Unit (SIMLU) is running a new campaign to raise awareness of other options that are available to families, including government grants and funding that they may be eligible to receive, credit unions, free debt advice and support from local communities, schools and charities.

Research commissioned by SIMLU last year found that 7% of respondents had encountered a loan shark either in their community or online. Across the wider Scottish population, this equates to around 300,000 people.

SIMLU operates a free and confidential 24-hour helpline – 0800 084 0878 – to offer immediate support with urgent issues as well as help to access local services such as credit unions, debt advice and support groups.
