## **Neighbourhood Warden Report March 2025**

## Patrols

In March, I was on foot patrol in the community for 109 hours 45 minutes. This allows me to complete Hotspot patrols and provide a high visibility presence in Horsham.

Patrol time included 58 hours 45 minutes in Denne. Most time of the time in Denne is spent in the town centre. This gives me an opportunity to link in with the shops and businesses, market, residents, and young people. However, I also covered the residential areas in Denne.

I spent 27 hours in Forest which included covering areas such as Bennetts Field and New Street.

I spent 24 hours in Trafalgar this month and visited Greenway school during pick-up times.

## Community engagement/events/meetings.

### Shoreham Airport trip with Age UK's Silver Bullet Club:

The Silver Bullet Club, who meet at the Coot Pub in Trafalgar on the first Thursday of each month, went on a group trip to Shoreham Airport. It was a great trip, and I was pleased to have the opportunity to support it. The members had a great time and a special thank you to David who organises the group so well. The Silver Bullet club is always open to new members and is a friendly and welcoming environment.



**Horsham Market:**

I continue to stay in close contact with Horsham Market and speak with the market stall holders. Horsham Market is a wonderful hub of the community, and I would encourage anyone to attend on a Thursday, Friday or Saturday.

**West Sussex Fire and Rescue Service Safety Meeting:**

We held our monthly WSFRS Safety Meeting in Albery House. This gives us an opportunity to talk about buildings and places that potentially could be of concern. We discussed the fires in Southwater and the break-ins at two fire stations that lead to a large amount of life-saving equipment being stolen.

## Sussex Police and Anti-Social Behaviour

**Sussex Police:**

As a Neighbourhood Warden I have regularly patrolled with our Police Community Support Officers (PCSOs) and continue to share Information with them. We have a dedicated 'Town Team' of six PCSOs. During March, I had approximately 32 calls with the PCSO Town Team, and we completed 20 joint patrols. Sussex Police have issued three Community Protection Warnings (CPWs) to individuals who were acting anti-socially in town and the CPWs contain conditions the individual must follow.

In Forest Neighbourhood, PCSO Christina Laws is the local PCSO. This month I attended a follow-up meeting regarding New Street in which several agencies lead by Horsham District Council and Sussex Police discussed our joint plan to improve this area and rejuvenate the communal space, (More info on this to come...)

In Trafalgar Neighbourhood, PCSO Kyle Berriman is the local PCSO. PCSO Berriman and I frequently meet to discuss Trafalgar Neighbourhood and attend community events together. I spoke with Kyle this month to discuss a few vulnerable residents, and we worked together to find the most appropriate support.

If there any community events you believe would benefit from a visit from the Neighbourhood Wardens and / or PCSOs then please get in touch, and this can be arranged.

**ASB:**

We issued a Community Protection Notice (CPN) this month to an individual who had been acting anti-socially. The CPN dictates what behaviours cannot continue and the available options of enforcement.

## Cycling

This month I have seen a reduction in cycling on West Street. I asked 4 cyclists to dismount, all 4 dismounted. I have received a report of anti-social cycling in Horsham Park. I have passed this on to the Neighbourhood Policing Team for awareness and will increase my patrols in Horsham Park.

Bike thefts are still prevalent, and members of the public can order their own anti-theft stickers from The Bike Register <https://www.bikeregister.com/>

I had 26 conversations described as 'Signposting' this month. This can be anything from our local foodbanks and community fridge to reporting abandoned trolleys. During our foot patrols

we spend a lot of time discussing with residents the support and resources available to them. Please see our resource page for the services we regularly signpost to.

### Safeguarding:

Our approach to safeguarding is changing slightly at Horsham District Council and new Safeguarding Champions are being trained within the Council. This is in response to WSCC having an incredibly high demand with safeguarding referrals. This will ensure we have tried to utilise all resources and services available before we complete an official safeguarding referral.

Safeguarding is still a constant responsibility and although I did not complete any official safeguarding referrals to WSCC in March, I continue to signpost and refer to services of support for those who require help.
