Your priorities are chosen quarterly and are based upon information gathered through NHL (Neighbourhood Link), social media, local engagement, and emerging crime trends. You have stated that the following key themes are important to you. #YouSaidWeDid

You Said	We did
ASB (Anti-Social Behaviour) – Ongoing issues with large groups of youths, particularly on public parks, fighting, playing loud music, being abusive, drinking and using drugs.	Increased <b>regular high visibility foot patrols</b> in affected parks during peak times (after school, early evening, weekends). Conducted <b>targeted deployments</b> based on community intelligence and incident logs. When behaviour escalated or persisted, we used section 35 Dispersal Orders in hotspot locations. Issued Community Resolutions/ ASB advice or warning letters to repeat offenders. We also submitted referrals for Acceptable Behaviour Contracts (ABCs)
Drugs – Reports of drug dealing and using at several addresses on the beat, attracting undesirables to the location and often resulting in ASB (Anti-Social Behaviour) and disorder at the addresses.	Conducted regular <b>H2H enquiries</b> and reassurance visits to gather further community intelligence. Liaised with the <b>Intel Unit</b> to develop actionable information and link addresses to wider criminal networks.
Road Safety – Speeding of vehicles along several roads on the beat, breaches of weight restrictions and bridge strikes all lead to a feeling amongst the community that road safety is an issue.	We Conducted <b>high visibility speed checks</b> at key complaint locations using handheld enforcement devices and support from the Roads Policing Unit (RPU). Deployed <b>speed indicator devices (SID)</b> to capture data, improve driver compliance and identify peak offending times.

## News

Storm Goretta arrived in some places last month and The Met Office issued an Amber Warning for heavy snow and strong winds. We received a large number of calls about vehicles succumbing to the weather and leaving occupants stranded. However, others including myself were left bitterly disappointed after Storm 'Forgett' missed us entirely!

PCSO Steve and PCSO Ebonie from the Beat Team attended the lunch club at St Francis Community Centre, Hinckley, where they spent time engaging with local residents. The visit provided a valuable opportunity for informal discussion and continued community engagement. Thank you to St Francis Community Centre for the warm welcome.

PCSO's Steve and Ebonie took part in a Joint Agency Community Conversations patch walk on the 14<sup>th</sup> January around Magee Close and Teign Bank Road. We were joined by Leicestershire Fire and Rescue Service, an Officer from Family Help at Leicestershire County Council, Councillor Michael Mullaney and representatives from various departments within HBBC. In just 2 hours we'd recorded 52% of the doors knocked were answered, 50% of which were council tenants and 50% private owned/rented. We gathered valuable information on:



Specific needs for accessing services – helping us tailor services and ensure fair access. Households with multiple vulnerabilities – including physical and mental health conditions. Digital exclusion – 70% of tenants we spoke to either don't know how to use MyHousing or lack internet/device access. We'll use this insight to plan support.

**Services delivered on the doorstep—8 new repairs reported**, including: 4 damp and mould cases – triaged and will be responded to within Awaab's Law timeframes, **4 new ASB reports** and follow-up on 3 existing cases, **Home safety checks** by the fire service, **Crime and ASB discussions** with PC Steve Pritchard and PCSO Ebonie, **Mental health advice** given to 14% of households, plus leaflets for local support. **Smoke alarms tested** in 26% of properties. **Lifeline system checked** in one property. So what happens next?; HBBC will raise jobs with the repairs team and book appointments, Prioritise damp and mould cases for urgent action. Update housing systems with the information shared to ensure inclusive access. Use tenant insights to shape future policies and services. Develop a plan to support tenants with MyHousing sign-up and digital access. Assign all ASB reports to cases for action by the HBBC specialist team, working with us where needed.

The next one is a 'drop in' session on the 11<sup>th</sup> February. Our next patch walk is on the 11<sup>th</sup> March. Save the date!
