I'm back in the village after supervising the wider Warden team for 4 years and am looking to get myself stuck in again to everything Pulborough!! I've been in post for just under 2 weeks so not much to report for now. We have a second Warden joining the team in August and her name is Lottie. I'll be showing her around the parish and introducing her to the community.

I attended the village market to say hi and reintroduce myself to the community. Needless to say, not much has changed! I had lots of good engagement and came away with some questions from the community that I will go on to support them with.

Vulnerable People

I visited an older vulnerable resident to check in with them to see how they're doing as their mobility has decreased. All ok.

Clubs and groups

I've been in contact with Age UK regarding the future of the Silver Bullet and will look to see how we can improve attendance in the Autumn. A big thank you to Tom at Macklin's for hosting this so far. The Dungeons and Dragons club continues to meet in Storrington every second Saturday. I also attended the Wednesday Wellbeing Café to engage with residents.

Fly-Tipping/Littering/Graffiti

I have reported 2 lots of fly-tipping so far which have been removed by our cleansing team.

I've been made aware of the broken gate at the entrance to the Brooks at the bottom of Barn House Lane. This is being investigated and repaired by WSCC Public Rights of Way team.

I reported the broken office swivel chair, that has been sitting outside Domino's for a while, to our fly-tipping team.

Other

I reported a dangerously positioned A board to Highways. This board was obstructing the line of sight for drivers exiting at a T junction. Glad to say the board has now moved.

I've received reports of overgrown hedges and have advised residents to take a photo and send it to Highways for their consideration.

I also received a query regarding wheelie bins blocking a pavement. I will keep an eye on the area and contact our waste team if the issues continue.

I've had queries regarding the Catholic Church site along Church Place being insecure. I've spoken to the developers who have made it secure and are waiting for planning permission to move forward on developing the site.

I attended a full Warden team meeting to share ideas and talk through everything 'Warden'.

I supported and helped a resident who wishes to donate some good quality furniture to someone in need and have signposted her to the Wholesome Warehouse in Storrington.

I had a query regarding a red car with no number plates driving around an area. This is difficult to deal with as we don't know who it belongs to but I will continue to patrol the area in question.

I liaised with a resident regarding a motorcyclist that was doing wheelies and wheel spins in Rectory Lane. This has hopefully been captured on dashcam of another vehicle and been reported to Operation Crackdown.

Another resident approached me regarding some suspicious activity by a company. I've advised them to contact the company directly with their concerns, for them to follow up.

I've had reports of vapes and alcohol being sold to underage people. I am working with Trading Standards on this matter.
