

THE ANTI-SOCIAL BEHAVIOUR, CRIME AND POLICING ACT
2014 AMBER VALLEY BOROUGH COUNCIL
PUBLIC SPACES PROTECTION (HEANOR MARKET PLACE)
ORDER 2024

Amber Valley Borough Council (in this Order called "the Authority") in exercise of its powers under Section 59, 64 and 72 of the Anti-Social Behaviour Crime and Policing Act 2014 ("the Act") and under all other powers hereby makes the following Order:

1. This Order shall come into operation on 25th September 2024 and shall have effect until and including 24th September 2027.
2. This Order relates to the areas as shown edged red on the attached Plan ("the Restricted Area").
3. The Council is satisfied that the conditions set out in Section 59(2) of the Act have been met. Namely that anti-social behaviour and criminal activities have and are taking place within the Restricted Area through nuisance behaviour. These activities have a detrimental effect on the quality of life of those in the locality.
4. The Council is further satisfied that the conditions set out in Section 59(3) of the Act have been met. Namely, that the effect or likely effect of the activities is, or is likely to be, of a persistent or continuing nature and that these activities are unreasonable and justify the restrictions imposed by this Order and that it is in all the circumstances expedient to make this Order for the purpose of reducing crime and/or anti-social behaviour in a public place.
5. The effect of this Order is to impose the following conditions on the Restricted Area:
 - An authorised person where they reasonably suspect, may request that a group of three or more within the restricted area acting in such a manner as to cause harassment, alarm or distress to any persons immediately disperse and not return to the restricted area within 48 hours.
 - An authorised person may request a person to dismount if they are cycling, skateboarding, scootering and hover-boarding or using similar devices electronic or motorised within the restricted area where they reasonably suspect that the person is riding in a malicious and/or dangerous manner as to cause harassment, alarm or distress to any person within that area.
 - A person is prohibited from wearing face coverings in an attempt to conceal their identity to cause harassment, alarm or distress to any person; this includes scarves, balaclavas and masks. This would not include face covering worn in respect of religious or cultural beliefs.
 - A person is prohibited from playing unreasonably loud music, from any device or vehicle within the restricted area that is causing or likely to cause harassment, alarm or distress to any other person.
6. A person, who fails to comply with any obligation imposed by this order, is guilty of an offence under section 67 of the Anti-Social Behaviour, Crime and Policing Act 2014 and is liable on summary conviction to a fine not exceeding level 3 on the standard scale or a fixed penalty notice of a maximum £100.


- 7 An "Authorised Officer of the Authority" means a Local Authority employee, a person designated by the Local Authority, a Police Officer or Police Community Support Officer who is authorised in writing by Amber Valley Borough Council for the purposes of giving directions under this Order.

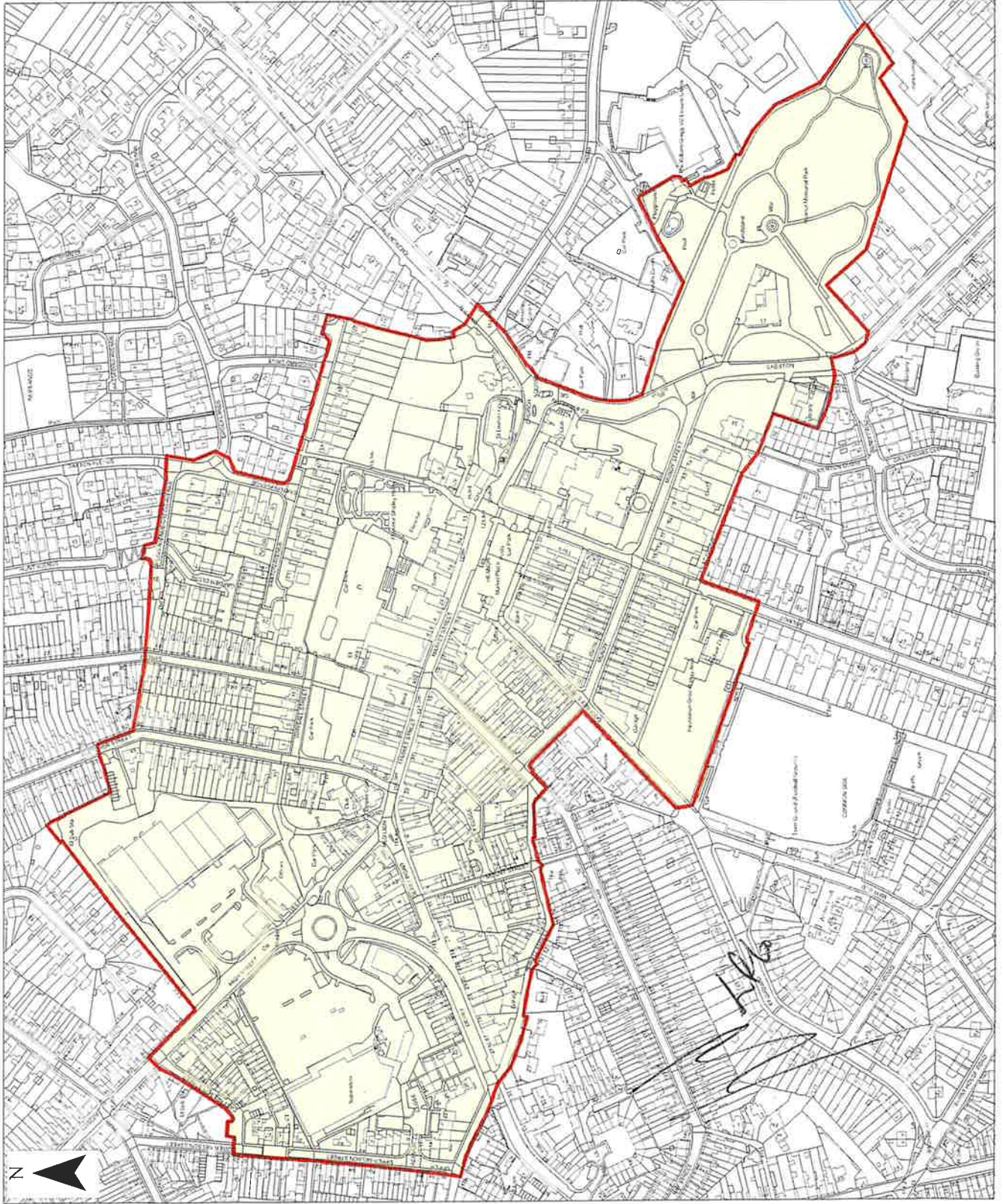
Schedule 1
