€ Following reports involving dogs not under control attacking other animals and livestock, we would like to politely remind dog owners of their responsibilities.

Tivestock worrying - Livestock worrying is a criminal offence and comes under the Dogs (Protection of Livestock) Act 1953.

'Worrying' is where a dog attacks or chases livestock causing injury or suffering.

A farmer is allowed to kill the dog if it's worrying their livestock.

Mg Dogs out of control in public places - It's an offence to let a dog be dangerously out of control whether that's in public or private.

A dog is considered to be out of control if it: injures someone - makes someone worried that it might injure them

A court could also decide that your dog is dangerously out of control if:

it attacks someone's animal


the owner of an animal thinks they could be injured if they tried to stop your dog attacking their animal

You can get an unlimited fine or be sent to prison for up to 6 months (or both) if your dog is dangerously out of control. You may not be allowed to own a dog in the future and your dog may be destroyed. Please always keep your dog under control around other animals and if you see a dog on the loose worrying animals, report it to Police.

# Rogue traders: what you need to know

Now the warmer weather is approaching, you may consider making improvements to your house and garden.

Be cautious of rogue traders who may knock on your door and offer to do work to your home or garden. Things to look out for include:

- Remember to ask for identification and understand the terms and conditions of the work.

# Electric bikes: don't get a shock, know the rules

We realise that the increasing popularity of e-bikes has led to more people riding on pavements and roads. We know this has caused significant public nuisance. If you have an e-bike, it's important you are aware of the rules to keep yourself and others safe.

According to current Government legislation, e-bikes can be used on public roads without a licence or insurance provided that:

- They are pedal assisted, bikes are fitted with pedals that are capable of propelling the bike.
- Maximum continuous rated power of the electric motor does not exceed 250 watts.
- Electrical assistance must cut off when the vehicle reaches 15.5 mph (25 kph).
- Therider is not under 14 years of age.



If your bike does not fit these guidelines, you can only ride your e-bike on a road if it is registered, taxed and you have a valid driving licence. You must also wear a motorcycle helmet and insure your vehicle. For more information, visit GOV.uk website.
