### Mobile phone theft survey

Statistics show that phone thefts have been increasing, particularly in urban areas. According to the Crime Survey for England and Wales, an estimated 78,000 people had phones or bags snatched from them on the street last year.

That is a 153% increase on the number of incidents.

#### STAY VIGILANT

Be cautious of unexpected cold callers at your door to avoid distraction burglaries. Don't let strangers inside your home, even if they appear to be from a reputable company.

#### SECURITY SYSTEMS

Consider investing in a home security system. Visible alarm boxes, security cameras, & video doorbells can deter thieves and alert you and your neighbours to suspicious activity.

#### LOCK UP

Before you leave the house, check that all doors and windows are closed and locked securely, even if you are only going to be out for a short while. Use additional locks and security devices where possible. Most thefts are committed by opportunists who are looking for any weakness they can exploit.

Prevention is key; with a few simple measures, you can reduce the chances of your home being targeted.

### DON'T ADVERTISE YOUR BELONGINGS

Packaging from expensive purchases should be disposed of sensibly. Leaving packaging outside your home could potentially advertise desirable items at your property.

#### LIGHTING

Install outdoor lighting to increase visibility around your property. Timer switches on internal lights and radios give the appearance that someone is at home.

#### PLAN AHEAD

Make arrangements for your home to appear occupied when you are away.

Cancel regular deliveries and ask a neighbour to check your


### Are you worried someone might be stalking you?

The Suzy Lamplugh Trust has an online 'Am I being stalked?' tool which can help you understand your rights and take the next steps towards safety.

It can assist you with:

- Understanding the law on stalking and harassment in the UK
- How to document incidents
- How to report the behaviours to the police
- Accessing local services like advocacy, housing and mental health support

### Victims of crime have received record compensation from criminal funds

New figures released show that almost £50 million taken from criminals was returned to victims, a 165% increase on the previous year and the highest amount in over half a decade.

This comes as police recovered almost £300 million in criminal assets. Law enforcement agencies have robust tools to trace, seize, and recover assets acquired through illegal activities under the Proceeds of Crime Act 2002 (POCA). These assets can range from cash and property to vehicles and luxury items.

Criminal funds have also been reinvested to boost law enforcement's ability to secure our borders. This includes funding the cutting edge Multi Agency Cash Cell at the border, which brings together government and law enforcement agencies to disrupt the flow of criminal finance into the country. ### **Hate Crime Awareness Week**

National Hate Crime Awareness Week runs from 11 to 18 October 2025. The main objective of National Hate Crime Awareness Week #NationalHCAW is to encourage the authorities (Government, Police and Councils), key partners (anti-hate crime charities, business and voluntary sectors), and communities affected by hate crime to work together to tackle local hate crime issues.

Hate crimes are any crimes that are targeted at a person because of hostility or prejudice towards that person's:

- disability
- · race or ethnicity
- · religion or belief
- sexual orientation
- transgender identity

They can be committed against a person or property. A victim does not have to be a member of the group at which the hostility is targeted. In fact, anyone could be a victim of a hate crime. This awareness week aims to spread an annual message of H.O.P.E.

H for raising Hate crime awareness,

O for improving Operational responses to hate crime,

P for Preventing hate crime, and

E for community Engagement.

## Neighbourhood Watch speaks to the London Assembly about the experiences of young people

The London Assembly Police and Crime Committee recently held a session examining neighbourhood policing and the experiences of young Londoners.

Our young people's programme manager Ashley Fontaine spoke to the committee with Jessica West Principal at Ark Walworth Academy and Omar Alleyne-Lawler Police Engagement Manager at Hope in Haringey.

They discussed how safe young Londoners feel and explored:

- How safe young people feel in their communities
- · What the Met is doing to engage with young people and build trust in policing
- How the Met's operation in schools may be affected by cuts to Safer Schools Officers.
